  - b) Pursuant to Exhibit 10, **DEFINITIONS**, the definition of "**Participating JBE/Entities**" and "**Participating Entity**" is deleted in its entirety and replaced with the following:
 

**"Participating JBE/Entities"** and "**Participating Entity**" are the 58 Superior Courts of California (collectively, "Superior Courts" or "trial courts"), including the Courts listed in Attachment #1 to this Agreement, and the Judicial Council of California.

4. Except as provided in this Amendment, all terms, and conditions of the Agreement, as previously amended, shall remain in full force and effect.
