



# Community Assistance, Recovery, and Empowerment Act

### **CARE Act Court Locations and Timeline for Implementation**

#### **Background**

The Community Assistance, Recovery, and Empowerment (CARE) Act authorizes specified adult persons to petition a civil court to create a voluntary CARE agreement or a court-ordered CARE plan that may include treatment, housing resources, and other services for persons with untreated schizophrenia and other psychotic disorders.<sup>1</sup>

The CARE Act will be implemented in a phased-in approach, with counties separated into two cohorts. Cohort 1 includes seven counties—Glenn, Orange, Riverside, San Diego, San Francisco, Stanislaus, and Tuolumne—and will begin implementing no later than October 1, 2023. The remaining 50 counties (Cohort 2) will begin implementing CARE no later than December 1, 2024. Los Angeles County will be accelerating the implementation of the CARE Act to December 1, 2023—one year ahead of the scheduled Cohort 2 implementation date.
