1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Agreement referenced above. As set forth in the Agreement, the term "Contractor" refers to **Howroyd Wright Employment Agency, Inc., dba: AppleOne Employment Services**, and the term "Judicial Council" refers to the **Judicial Council of California**.

2. Title of the Agreement: **Temporary Staffing Services**

3. This Amendment becomes effective on **June 24, 2017.**

4. The parties agree to amend the Agreement as follows:

4. A The purpose of this Amendment is to exercise the First Option Term in accordance to Section 34 of Exhibit B of the Agreement; thereby extending the Term of the Agreement for one (1) year.

4. B Contractor will continue to perform temporary staffing agency services throughout the term of the Master Agreement, in accordance with Exhibit E, Description of Services.

4. C. The expiration date of the Agreement is hereby changed from June 23, 2017 to June 23, 2018.


6. Except as provided in this Amendment, all terms and conditions of the original Agreement (as previously amended, if applicable) remain in full force and effect.
