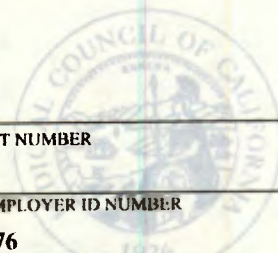



1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Agreement referenced above. As set forth in the Agreement, (the "Master Agreement"), the term "Contractor" refers to **Dunbar Armored, Inc.**, and the term "Judicial Council", "AOC", or "State" refers to the **Judicial Council of California**.
2. The title of this Master Agreement is: **Armored Car Services**. The parties agree that the Contractor will furnish to the 58 Superior Courts of California, the Appellate Courts, the Supreme Court of California, and the Judicial Council (individually referred to as a member of the "Purchasing Group" or "Customer"), services and materials as required in this Master Agreement.  
The title listed above is for administrative reference only and does not define, limit, or construe the scope or extent of the Agreement.
3. This Amendment becomes effective on **July 1, 2015** and expires **June 30, 2016**.
4. The parties agree to amend the Master Agreement as follows:
  - a. The purpose of this Amendment is to: i) exercise the third option term; ii) change the Contact Information for the Judicial Council Contract Manager; and iii) update Exhibit B, Payment Provisions.
  - b. Exhibit B, Payment Provisions, Revision No. 1, is hereby deleted and in its entirety and replaced with Exhibit B, Payment Provisions, Revision No. 2, attached hereto and incorporated herewith.
  - c. Pursuant to Exhibit C, Paragraph 2, Term, the Judicial Council hereby exercises its option to extend the Master Agreement for the **Third Option Term** period beginning **July 1, 2015** and ending on **June 30, 2016**.
  - d. Exhibit C, Paragraph 23, Request; Communication; Notice (a) and (b), as amended is hereby deleted in its entirety and replaced with Exhibit C, Paragraph 23, Request; Communication; Notice (a) and (b), attached hereto and incorporated herewith.
  - e. Contractor shall continue to provide Armored Car Services, including furnishing to the 58 Superior Courts of California, the Appellate Courts, the Supreme Court of California, and the Judicial Council (individually referred to as a member of the "Purchasing Group" or "Customer"), services and materials as required in this Master Agreement.
  - f. The expiration date of the Master Agreement is hereby changed from **June 30, 2015** to **June 30, 2016**.
5. Except as provided in this Amendment, all terms and conditions of the original Agreement remain in full force and effect.


